THE JOURNAL CONTENTS WILL BE THE FOLLOWING:

- **EDITORIAL.** A space reserved for the editor's communications.
- **LETTERS TO THE EDITOR.** Discussions and opinions regarding recently published subjects.
- **ANSWERS FROM THE EDITOR AND/OR THE AUTHOR(S).** A space reserved for answering the readers' questions.
- **ORIGINAL ARTICLES.** Scientific and technological reports on basic and/or applied science, with the results being the product of original research.
- **SYSTEMATIC REVIEWS.** Up-to-date literature reviews regarding a specific subject, using valid and quality scientific criteria.
- **CLINICAL REPORT.** Presentation and discussion of one or many concrete and novel cases that are of great academic value.
- **ARTICLES FOR REFLECTION.** Articles with reflexive and critical content regarding a specific subject.
- **SUMMARIES OF RESEARCH.** Summaries of highly pertinent and academically valuable previously published research papers.
- **SPACE FOR ACADEMIC AND SCIENTIFIC DISSEMINATION.** A space for publishing research projects still in progress and/or videos, presentations and summaries of academic events.

The specific subjects will be framed within the context of Veterinary Medicine and Animal Husbandry.

INSTRUCTIONS FOR THE AUTHORS

Our reception of articles doesn't imply an obligation to publish; they will be subject to review by the Editorial Committee and submitted to corrections before publication.

The deadline for articles for volume 2 # 2, will be October 30, 2007. All information regarding their delivery must be sent to the following postal address:

The articles must be written entirely in Portuguese, English or Spanish.

The article must be laid out in 1.5 spacing and use ARIAL .12 font.



One full file (including text, photos, tables, videos, etc.) (software: WORD), and another file only with individual figures and videos (security backup). The presentation of results must use standard deviation and not mean standard error.

The scientific names should be written in italics, and the initial of the Genus should be written in upper case, while the initial of the species should be in lower case (e.g. *Bacillus subtilis*, *Escherichia coli*, etc.). Bibliography should be presented alphabetically and references must be numerical, and use superscript.

THE FOLLOWING WILL BE THE FORMAT FOR ORIGINAL ARTICLES:

- Article title in English and Portuguese.
- Name(s) and surname(s) of the author(s). A footnote should contain the entity or the institution they belong to, the section or the Faculty, their research group, academic degrees, postal address and e-mail.
- Abstract in Portuguese and English.
- Keywords in Portuguese and English. From three to a maximum of five words.
- Introduction.
- Materials and Methods.
- Results.
- Discussion.
- Conclusions.
- Thanks.
- Bibliographical references, in alphabetical order.
- The quotes within the text will be numerical and use superscript.

FOR SYSTEMATIC REVIEWS, THE FORMAT WILL BE THE FOLLOWING:

- Title of the article in Portuguese and English.
- Name(s) and surname(s) of the author(s). A footnote should contain the entity or the institution they belong to, the section or the Faculty, their research group, academic degrees, postal address and e-mail.
- Abstract in Portuguese and English.
- Keywords in Portuguese and English. From three to a maximum of five words.
- Introduction.
- Titles and subtitles alluding to the subject under review. The author or authors must argue for or against the information contained in the up-to-date review; besides, they will make a critical contribution to the strengths, weaknesses and opportunities presented by the subject under review
- Conclusions.
- Thanks.
- Bibliographical references, in alphabetical order.
- The quotes within the text will be numerical and use superscript.



FOR CLINICAL REPORT, THE FORMAT WILL BE THE FOLLOWING:

- Title of the article in Portuguese and English.
- Name(s) and surname(s) of the author(s). A footnote should contain the entity or the institution they belong to, the section or the Faculty, their research group, academic degrees, postal address and e-mail.
- Abstract in Portuguese and English.
- Keywords in Portuguese and English. From three to a maximum of five words.
- Introduction.
- Patient evaluation.
- Focus of the treatment.
- Discussion.
- Conclusions.
- Thanks.
- Bibliographical references, in alphabetical order.
- The quotes within the text will be numerical and use superscript.

FOR RESEARCH SUMMARIES, THE FORMAT WILL BE AS FOLLOWS:

- Title of the article in Portuguese and English.
- Name(s) and surname(s) of the author(s). A footnote should contain the entity or the institution they belong to, the section or the Faculty, their research group, academic degrees, postal address and e-mail.
- Summary in Portuguese and English. Shouldn't exceed 200 words in each language.
- Keywords in Portuguese and English. From three to a maximum of five words.

FOR THE SPACE FOR ACADEMIC AND SCIENTIFIC DISSEMINATION, THE FORMAT WILL BE AS FOLLOWS:

- Title of the publication in Portuguese and English.
- Name(s) and surname(s) of the author(s). A footnote should contain the entity or the institution they belong to, the section or the Faculty, their research group, academic degrees, postal address and e-mail.
- Abstract in Portuguese and English.
- Keywords in Portuguese and English. From three to a maximum of five words.
- Introduction (if it is an article for reflection).
- Titles and subtitles alluding to the subject for reflection (if it is an article for reflection).
- Names of the links to presentations, videos, animations, etc.
